All requirements of the original RFQ except those requirements specifically changed by this addendum shall remain in effect. In the event of any inconsistency between information provided in the RFQ and information in this addendum, the information in this addendum shall prevail.

Addendum 1 contains questions submitted by interested parties and the official responses. These responses shall amend or clarify the requirements of the RFQ.

A. Questions and Responses

1. **Question:**

Regarding the required three letters of reference: Our project involves a partnership with another agency to provide services. Should all three letters reference our qualifications at Connecticut Children's, or should one letter demonstrate the qualifications of our partner agency?

Response:

If the response to the RFQ is submitted from co-respondents, three (3) letters of reference from each respondent are required. If the response to the RFQ is submitted by one (1) entity, (the respondent) and the other is in a subcontractor capacity; we require the respondent to provide three (3) letters of reference and the subcontractor to provide three (3) letters of reference.

2. **Question:**

Regarding item IV. SUBMISSION OUTLINE: Can you please clarify the difference between item "F. Qualification Submission" and item "G. Responses to D. QUALIFICATION SUBMISSION"?

Response:

"F. Qualification Submission" is the actual **title** page the Respondent must have that will precede their responses to "G. Responses to D. QUALIFICATION SUBMISSION".

3. **Question:**

Regarding the eligibility requirements, do you have to presently have professionally trained clinical staff on board or can you hire per this RFQ?

Response:

The Respondent must have a professionally trained clinical staff committed to work on the project. Resumes and letters of commitment must be included in the response to the RFQ.

4. **Question:**

Do "professionally trained, credentialed, clinical personnel" include individuals with a LCSW, M.A.-level nursing degree, a Ph.D in Industrial-Organizational Psychology or a Ph.D in management?

Response:

The intent of the program is to provide staffing that includes persons with client intervention roles that are healthcare related such as nurses, doctors, clinical social workers and clinical psychologists.

5. **Question:**

What % of the previous contract budget was allocated to each service we must provide (e.g., % allocated to developing curricula, % allocated to consultations)?

Response:

The budget is not allocated by service elements.

6. **Question:**

On page 17 of the RFQ, the first bullet point discusses goals of the initiative. Can you be more specific as to the scope of the necessary services we must provide (e.g., how often must training sessions be held, how many training sessions must be completed, how many sessions must be held per participant, who will the audience be for the training sessions, and what amount of professional educational materials and web-based resources we must provide)?

Response:

The successful respondent will provide services to the healthcare professional community. The Department is seeking the respondent to identify its' maximum services in these key areas. Once a respondent is awarded the right to negotiate a contract, more specific details will be discussed.

7. **Question:**

How will success of our contract be measured?

Response:

The success of the contract will be measured through outcome measures and program reporting that will be established between the Department and the successful respondent.

8. **Question:**

After submission of our contract proposal, who will be the point of contact that can be reachable concerning this Domestic Violence Prevention Training program?

Response:

The Department of Social Services (DSS) is seeking submissions from organizations and agencies qualified to conduct a professional Domestic Violence (DV) prevention, education, and consultation project to reduce the rate of physical assaults to individuals by current or former intimate partners.

***Please note**, for the purpose of this proposal, intimate partner violence (IPV) is defined as actual or threatened, physical or psychological abuse by an intimate partner.*

Purpose: The DV project shall serve to improve the health care system's response to incidences of DV by providing health, mental health, and social service providers with the awareness and skills necessary to identify, plan for the safety of individuals, and refer victims or potential victims of DV to appropriate service providers.

This RFQ proposes to address one part of a comprehensive system to address the needs of clients who may be impacted by DV. This RFQ addresses the preparation of health, mental health, and social service providers for recognition of clients who may have IPV issues to provide appropriate intervention.

Eligibility Requirements: Organizations and agencies must meet the eligibility requirements listed below.

1. Be a public or private organization or community based agency located within Connecticut;
2. Have a demonstrated capacity to conduct statewide public health and clinically focused IPV prevention training for adult health, mental health, social service and public health professionals, paraprofessionals, students and others; and
3. Have in employment, professionally trained, credentialed, clinical personnel such as a medical doctor, Ph.D., psychologist, and/or graduate level registered nurse.

Qualification Requirement: Organizations and agencies must have a minimum of three (3) years experience providing training to adult health, mental health, social service and public health professionals, regarding IPV.

I. GENERAL INFORMATION

■ A. INTRODUCTION

1. RFQ Name. **Domestic Violence Prevention Training for Health Care Providers (DVPT_RFQ_121714)**

2. **Summary.** The Department of Social Services (DSS) is seeking submissions from organizations and agencies qualified to conduct a professional Domestic Violence (DV) prevention, education and consultation project in order to reduce the rate of physical assault by current or former intimate partners. This project shall serve to improve the health care system's response to DV by providing health, mental health, social service and other providers with the awareness and skills necessary to identify victims or potential victims of DV, establish safety plans as well as referrals for such individuals.

In addition, the successful organization or agency shall engage in activities that enhance the coordination of services consonant with [Family Violence Prevention Services](#) (FVPS) grant, provided as a hyperlink, administered by the U.S. Department of Health and Human Services' Administration for Children and Families and the Patient Protection and Affordable Care Act. This includes increasing the number of physicians, nurses, nursing and medical students, social workers and other health, mental health and social service professionals who are trained in the identification and referral of people who are victims or potential victims of family violence. The Respondent will provide training, program materials, and client-centered telephone consultation to health, mental health, and social service providers regarding intimate partner violence (IPV) issues. Additionally, issues of healthcare disparities will be attended to during training sessions as appropriate.

4. **Eligibility.** Organizations and agencies must meet the eligibility requirements listed below:
 - a. Be a public or private organization or community based agency located within Connecticut;

- b. Have a demonstrated capacity to conduct statewide public health and clinically focused IPV prevention training for adult health, mental health, social service and public health professionals, paraprofessionals, students and others; and
- c. Have in employment, professionally trained, credentialed, clinical personnel such as a medical doctor, Ph.D., psychologist, and/or graduate level registered nurse.

5. Minimum Qualifications of Respondents. To submit a response to this RFQ, a Respondent must have the following minimum qualification:

Have a minimum of three (3) years experience providing IPV training to adult health, mental health, social service and public health professionals.

The Department reserves the right to reject the submission of any Respondent in default of any current or prior contract.

6. Procurement Schedule. See below. Dates after the due date for submissions ("Submissions Due") are target dates only (*). The Department may amend the schedule, as needed. - 7. Letter of Intent.** Prospective Respondents are encouraged, but not required to submit a Letter of Intent (LOI). The LOI is non-binding and does not obligate the sender to submit qualifications. The LOI must be submitted to the Official Contact by e-mail by the deadline established in the Procurement Schedule. The LOI must clearly identify the sender, including name, postal address, telephone number, and e-mail address.
- 8. Inquiry Procedures.** All questions regarding this RFQ or the Department's procurement process must be submitted to the Official Contact before the deadline specified in the Procurement Schedule. The early submission of questions is encouraged. Questions will not be accepted or answered verbally – neither in person nor over the telephone. All questions received before the deadline will be answered. However, the Department will not answer questions when the source is unknown (i.e., nuisance or anonymous questions). Questions deemed unrelated to the requirements of the RFQ or the procurement process will not be answered. At its discretion, the Department may or may not respond to questions received after the deadline. The Department may combine similar questions and give only one answer. All questions and answers will be compiled into a written addendum to this RFQ. If any answer to any question constitutes a material change to the RFQ, the question and answer will be placed at the beginning of the addendum and duly noted as such. The agency will release the answers to questions on the date established in the Procurement Schedule.

The Department will publish any and all amendments or addenda to this RFQ on the State Contracting Portal and on the Department's RFQ Web Page. At its discretion, the Department may distribute any amendments or addenda to this RFQ to prospective Respondents who submitted a Letter of Intent. **Submissions must include a signed Addendum Acknowledgement, which will be placed at the end of any and all amendments or addenda to this RFQ.**

9. **Submission Due Date and Time.** The Official Contact or an appointed designee by the Official Contact is the only authorized recipient of submissions submitted in response to this RFQ. One (1) original and one (1) hard copy of the submission with one (1) conforming electronic copy on disk of the original proposal must be mailed or hand-delivered to the Official Contact or an appointed designee by the due date and time. Faxed proposals will not be evaluated. A postmark date shall not be accepted as the basis for meeting the proposal due date and time. Respondents should not interpret or otherwise construe receipt of a proposal after the due date and time as acceptance of the proposal, since the actual receipt of the proposal is a clerical function. The Department suggest the Respondent use certified or registered mail, or a delivery service such as United Parcel Service (UPS) to deliver the original hard copy of the proposal. When hand-delivering proposals, Respondents should allow extra time to comply with building security and delivery procedures.

The hand-delivered original and one hard copy of the proposal can be delivered to the lobby at the Department of Social Services, 55 Farmington Avenue, Hartford, CT 06105-3730. Proceed to the security desk and the Official Contact or designee will be called to receive the proposal and provide the Respondent or courier with a receipt. Visitor parking is available across the street from 55 Farmington Ave.

Proposals shall not be considered received until they are in the hands of the Official Contact or another representative of the DSS Contract Administration and Procurement Unit designated by the Official Contact and e-mailed to the Official Contact. At the discretion of the Departments, late proposals may be destroyed or retained for pick-up by the submitters.

10. **Multiple Submissions.** Multiple submissions are not an option with this procurement.

11. **Declaration of Confidential Information.** Respondents are advised that all materials associated with this procurement are subject to the terms of the Freedom of Information Act (FOIA), the Privacy Act, and all rules, regulations, and interpretations resulting from them. If a Respondent deems that certain information required by this RFQ is confidential, the Respondent must label such information as CONFIDENTIAL. In Section C of the submission, the Respondent must reference where the information labeled CONFIDENTIAL is located in the submission. *EXAMPLE: Section G.1.a.* For each subsection so referenced, the Respondent must provide a convincing explanation and rationale sufficient to justify an exemption of the information from release under the FOIA. The explanation and rationale must be stated in terms of (a) the prospective harm to the competitive position of the Respondent that would result if the identified

information were to be released and (b) the reasons why the information is legally exempt from release pursuant to C.G.S. § 1-210(b).

12. Conflict of Interest - Disclosure Statement. Respondents must include a disclosure statement concerning any current business relationships (within the last three (3) years) that pose a conflict of interest, as defined by C.G.S. § 1-85. A conflict of interest exists when a relationship exists between the Respondent and a public official (including an elected official) or State employee that may interfere with fair competition or may be adverse to the interests of the State. The existence of a conflict of interest is not, in and of itself, evidence of wrongdoing. A conflict of interest may, however, become a legal matter if a Respondent tries to influence, or succeeds in influencing, the outcome of an official decision for their personal or corporate benefit. The Department will determine whether any disclosed conflict of interest poses a substantial advantage to the Respondent over the competition, decreases the overall competitiveness of this procurement, or is not in the best interests of the State. In the absence of any conflict of interest, a Respondent must affirm such in the disclosure statement. *Example: "[name of Respondent] has no current business relationship (within the last three (3) years) that poses a conflict of interest, as defined by C.G.S. § 1-85."*

■ D. SUBMISSIONS FORMAT

1. **Required Outline.** All submissions must follow the required outline presented in Section IV - Submission Outline. Submissions that fail to follow the required outline will be deemed non-responsive and not evaluated.
2. **Cover Sheet.** The Cover Sheet is Page 1 of the submission. Respondents must complete and use the [Cover Sheet](#) form, which is embedded in this RFQ as a hyperlink.
3. **Table of Contents.** All submissions must include a Table of Contents that conforms to the required submission outline. (See Section IV.)
4. **Executive Summary.** Submissions must include a high-level summary of the submission, not exceeding one (1) single-sided page. The Executive Summary shall include the following information of the Respondent:
 - a. Be a public or private organization or community based agency located within Connecticut;
 - b. Have a demonstrated capacity to conduct statewide public health and clinically focused IPV prevention training for adult health, mental health, social service and public health professionals, students and others;
 - c. Have in employment, professionally trained, credentialed, clinical personnel such as a medical doctor, Ph.D., psychologist, and/or graduate level registered nurse; and
 - d. Have a minimum of three (3) years' experience providing IPV triaging to adult health, mental health, social service and public health professionals.
5. **Attachments.** Attachments other than the required Appendices or Forms identified in Section IV are not permitted and will not be evaluated. Further, the required Appendices or Forms must not be altered or used to extend, enhance, or replace any component required by this RFQ. Failure to abide by these instructions will result in disqualification.

■ E. EVALUATION OF SUBMISSIONS

1. **Evaluation Process.** It is the intent of the Department to conduct a comprehensive, fair, and impartial evaluation of submissions received in response to this RFQ. When evaluating submissions, negotiating with the successful Respondent, and offering the

right to negotiate a contract, the Department will conform to its written procedures for PSA procurements (pursuant to C.G.S. § 4-217) and the State's Code of Ethics (pursuant to C.G.S. §§ 1-84 and 1-85).

- 2. Evaluation Team.** The Department will designate an Evaluation Team to evaluate qualifications submitted in response to this RFQ. The contents of all submissions, including any confidential information, will be shared with the Evaluation Team. Only submissions found to be responsive (that is, complying with all instructions and requirements described herein) will be reviewed, rated, and scored. Submissions that fail to comply with all instructions will be rejected without further consideration. Attempts by any Respondent (or representative of any Respondent) to contact or influence any member of the Evaluation Team may result in disqualification of the Respondent.
- 3. Minimum Submission Requirements.** All submissions must comply with the requirements specified in this RFQ. To be eligible for evaluation, submissions must (a) be electronically received on or before the due date and time; (b) meet the Submission Format requirements; (c) follow the required Submission Outline; and (d) be complete. Submissions that fail to follow instructions or satisfy these minimum submission requirements will not be reviewed further. The Department will reject any submission that deviates significantly from the requirements of this RFQ.
- 4. Evaluation Criteria (and Weights).** Submissions meeting the Minimum Submission Requirements will be evaluated according to the established criteria. The criteria are the objective standards that the Evaluation Team will use to evaluate the technical merits of the submissions. Only the criteria listed below will be used to evaluate submissions. The criteria are weighted according to their relative importance. The weights are confidential.

 - Qualification Submission
 - Appendices
- 5. Respondent Selection.** Upon completing its evaluation of submissions, the Evaluation Team will submit the rankings of all submissions to the Department head. The final selection of a successful Respondent is at the discretion of the Department head. Any Respondent selected will be so notified and awarded an opportunity to negotiate a contract with the Department. Such negotiations may, but will not automatically, result in a contract. Pursuant to Governor M. Jodi Rell's Executive Order No. 3, any resulting contract will be posted on the State Contracting Portal. All unsuccessful Respondents will be notified by e-mail at the Department's discretion, about the outcome of the evaluation and Respondent selection process.
- 6. Debriefing.** After receiving notification of the outcome of the evaluation process from the Department, any Respondent may contact the Official Contact and request a Debriefing of the procurement process and its submission. If Respondents still have questions after receiving this information, they may contact the Official Contact and request a meeting with the Department to discuss the procurement process. The Department shall schedule and conduct Debriefing meetings that have been properly requested, within fifteen (15) days of the Department's receipt of a request. The Debriefing meeting must not include or allow any comparisons of any submissions with other submissions, nor should the identity of the evaluators be released. The Debriefing process shall not be used to change, alter, or modify the outcome of a competitive procurement. More detailed information about requesting a Debriefing may be obtained from the Official Contact.

- 7. Appeal Process.** Any time after the submission due date, but **not later than thirty (30) days** after the Department notifies Respondents about the outcome of a competitive procurement, Respondents may submit an Appeal to the Department. The e-mail sent date or the postmark date on the notification envelope will be considered “day one” of the thirty (30) days. Respondents may appeal any aspect of the Department’s competitive procurement; however, such Appeal must be in writing and must set forth facts or evidence in sufficient and convincing detail for the Department to determine whether during any aspect of the competitive procurement there was a failure to comply with the State’s statutes, regulations, or standards concerning competitive procurement or the provisions of the RFQ. Any such Appeal must be submitted to the Agency Head with a copy to the Official Contact. The Respondent must include the basis for the Appeal and the remedy requested. The filing of an Appeal shall not be deemed sufficient reason for the Department to delay, suspend, cancel, or terminate the procurement process or execution of a contract. More detailed information about filing an Appeal may be obtained from the Official Contact.
- 8. Contest of Solicitation or Award.** Pursuant to Section 4e-36 of the Connecticut General Statutes, “Any bidder or proposer on a state contract may contest the solicitation or award of a contract to a subcommittee of the State Contracting Standards Board...” More detailed information is available on the State Contracting Standards Board web site at <http://www.ct.gov/scsb/site/default.asp>.
- 9. Contract Execution.** Any contract developed and executed as a result of this RFQ is subject to the Department’s contracting procedures, which may include approval by the Department of Administrative Services and Office of the Attorney General.

Note:

Part I of the standard contract may be amended by means of a written instrument signed by the Department, the selected Respondent (contractor), and, if required, the Attorney General's Office. ■ B. ASSURANCES

By submitting qualifications in response to this RFQ, a Respondent implicitly gives the following assurances:

- 1. Collusion.** The Respondent represents and warrants that the Respondent did not participate in any part of the RFQ development process and had no knowledge of the specific contents of the RFQ prior to its issuance. The Respondent further represents and warrants that no agent, representative, or employee of the State participated directly in the preparation of the Respondent's submission. The Respondent also represents and warrants that the submission is in all respects fair and is made without collusion or fraud.
- 2. State Officials and Employees.** The Respondent certifies that no elected or appointed official or employee of the State has or will benefit financially or materially from any contract resulting from this RFQ. The Department may terminate a resulting contract if it is determined that gratuities of any kind were either offered or received by any of the aforementioned officials or employees from the Respondent, contractor, or its agents or employees.
- 3. Competitors.** The Respondent assures that the submission is not made in connection with any competitor submitting a separate submission in response to this RFQ. No attempt has been made, or will be made, by the Respondent to induce any competitor to submit, or not submit, qualifications for the purpose of restricting competition.

4. **Validity of Submission.** The Respondent certifies that the submission represents a valid and binding offer to provide services in accordance with the terms and provisions described in this RFQ and any amendments or attachments hereto. The submission shall remain valid for a period of 180 days after the submission due date and may be extended beyond that time by mutual agreement. 1. **Equal Opportunity and Affirmative Action.** The State is an Equal Opportunity and Affirmative Action employer and does not discriminate in its hiring, employment, or business practices. The State is committed to complying with the Americans with Disabilities Act of 1990 (ADA) and does not discriminate on the basis of disability in admission to, access to, or operation of its programs, services, or activities.
2. **Preparation Expenses.** Neither the State nor the Department shall assume any liability for expenses incurred by a Respondent in preparing, submitting, or clarifying any qualifications submitted in response to this RFQ.
3. **Exclusion of Taxes.** The Department is exempt from the payment of excise and sales taxes imposed by the federal government and the State. Respondents are liable for any other applicable taxes.
4. **Changes to Submission.** No additions or changes to the original submission will be allowed after submission. While changes are not permitted, the Department may request and authorize Respondents to submit written clarification of their submissions, in a manner or format prescribed by the Department, and at the Respondent's expense.

By submitting qualifications in response to this RFQ, a Respondent implicitly accepts that the following rights are reserved to the State:

1. **Timing Sequence.** The timing and sequence of events associated with this RFQ shall ultimately be determined by the Department.
2. **Amending or Canceling RFQ.** The Department reserves the right to amend or cancel this RFQ on any date and at any time, if the Department deems it to be necessary, appropriate, or otherwise in the best interests of the State.
3. **No Acceptable Submissions.** In the event that no acceptable qualifications are submitted in response to this RFQ, the Department may reopen the procurement process, if it is determined to be in the best interests of the State.
4. **Award and Rejection of Submissions.** The Department reserves the right to award in part, to reject any and all submissions in whole or in part, for misrepresentation or if the submission limits or modifies any of the terms, conditions, or specifications of this RFQ. The Department may waive minor technical defects, irregularities, or omissions, if in its judgment the best interests of the State will be served. The Department reserves the right to reject the submission of any Respondent who submits qualifications after the submission due date and time.
5. **Sole Property of the State.** All qualifications submitted in response to this RFQ are to be the sole property of the State. ■ A. DEPARTMENT OF SOCIAL SERVICES OVERVIEW

The Department of Social Services (DSS) administers and delivers a wide variety of services to children, families, adults, people with disabilities and the elderly, including health care coverage, child care, child support, long-term care and supports, energy assistance, food and nutrition aid, and program grants. DSS administers myriad state and federal programs and one-third of the state budget, currently serving more than 848,000 individuals in nearly 540,000 households (April 2014 data).

By statute, DSS is the state agency responsible for administering a number of programs under federal legislation, including the Food Stamp Act, the Older Americans Act, and the Social Security Act.

The Department is headed by the Commissioner of Social Services, and there are deputy commissioners for programs and administration. The agency delivers most of its programs through 12 field offices (including three benefits centers available by phone) located throughout the state, with central administrative offices located in Hartford. In addition, many services funded by the agency are available through community-based agencies and partner contractors. The agency has out stationed employees at hospitals to expedite Medicaid/HUSKY applications, and also works with community service providers to facilitate program applications.

Attached to the department for administrative purposes only are the Department of Rehabilitation Services, encompassing vocational rehabilitation services, services for the blind and visually-impaired and the deaf and hearing-impaired, and disability determination services; the Department on Aging; and the Child Day Care Council

■ B. PROGRAM OVERVIEW

This Domestic Violence Prevention Training for Health Care Providers project shall serve to improve the health care system's response to incidences of DV by providing health, mental health, and social service providers with the awareness and skills necessary to identify, plan for the safety of individuals, and refer victims or potential victims of DV to appropriate service providers.

The successful Respondent will work with the Department of Social Services (DSS/Department) and an outside organization that provides critical support to victims including counseling, support groups, emergency shelter, court advocacy, safety planning, and lethality assessment,

among other services. The purpose of working in conjunction with both DSS and another outside organization, is to conduct a professional education and consultation, domestic violence (DV) prevention project, in order to reduce the rate of physical assault by current or former intimate partners.

In addition, the successful Respondent will engage in activities that enhance the coordination of services consonant with [Family Violence Prevention Services](#) (FVPS) grant administered by the U.S. Department of Health and Human Services' Administration for Children and Families and the Patient Protection and Affordable Care Act. This includes increasing the number of physicians, nurses, nursing and medical students, social workers and other health, mental health and social service professionals who are trained in the identification and referral of people who are victims or potential victims of family violence, (FV). Additionally, issues of healthcare disparities will be attended to during training sessions as appropriate.

The goal of the initiative is to enhance the program participants' capacity to:

- Conduct ongoing DV training for all health care providers and allied staff of the health care system or facility.
- Institutionalize a comprehensive response to patients experiencing DV through the formal adoption and implementation of protocols and policies.
- Identify victims of DV through routine screening.
- Provide DV services through referral to local domestic violence/sexual assault programs or services within the health care setting.

■ C. RESPONSIBILITIES OF THE RESULTANT CONTRACTOR

1. The Successful Respondent shall administer the "HEALTH PROFESSIONAL OUTREACH" in accordance with the guidelines of the FVPS grant administered by the U.S. Department of Health and Human Services' Administration for Children and Families, which includes but is not limited to increasing the number of physicians, nurses, social workers and other health, mental health and social service professionals who are trained in the identification and referral of people who are victims or potential victims of FV.
2. The Successful Respondent's "HEALTH PROFESSIONAL OUTREACH" project director shall coordinate all aspects of the "HEALTH PROFESSIONAL OUTREACH" project, including but not limited to the development and maintenance of policies and procedures for monitoring, evaluating, and ensuring service quality of training activities and outcomes.

■ D. QUALIFICATION SUBMISSION

General – Responses for this section must describe the Respondent's ability and competence to perform the requirements specified in this RFQ.

1. The Successful Respondent shall operate the program with persons who have expertise in working with issues relating to batterers and/or suspected batterers, FV health care issues, child abuse, and other FV related issues.

2. Develop curricula, resources, background research on best practices, and some case consultation.
3. The "HEALTH PROFESSIONAL OUTREACH" project director, training, and consultation coordinators shall plan and conduct approximately on-site FV professional education training sessions.
4. Develop Web based materials to support provider education.
5. Facilitate access to continuing education credits/units for medical doctors, registered nurses, and master of social work clinical certification.
6. Plan and provide consultation, sometimes of a clinical nature, regarding FV issues to healthcare, social service, mental health, and public health providers at their facilities and via telephone.
7. Upon request, review and provide feedback to agencies, that participated in training, regarding their FV case consultation protocols and procedures.
8. Develop professional educational materials provided to the Department by the Successful Respondent that shall address diverse provider needs, as well as cultural and linguistic competence.
9. Develop, produce, and make available via web-based resources, client and provider regional resource guides to providers. These materials shall include a list of IPV and other related issue referral sources.
10. Update and/or develop an evaluation plan and conduct an impact evaluation of the professional education and consultation activities. In addition, evaluate outcomes of FV professional education sessions.
11. Conduct quarterly Program Evaluation meetings regarding gaps, barriers, challenges, and resources with respect to the provision of services. These meetings shall also address goals and outcomes, as well as how and when any deficiencies will be corrected.

The Department reserves the right to reject the submission of any Respondent in default of any current or prior contract.

To submit a responsive submission, the following information about the Respondent's qualifications and experience must be provided.

- a. A description of the Respondent's qualifications to perform the services required by this RFQ including demonstrated experience in D. Qualification Submission, 1-11 above. **A responsive submission must include** information addressing each qualification requirement, **1.-11., individually and not exceed a total of twelve (12) single-sided pages.**
- b. Current resume(s) of the project director and any other individual that will be providing services as described in this RFQ, not exceeding two (2) single-sided pages, as **Appendix 1.** The resumes must reflect qualifications including related experience and education; and

- c. Three (3) letters of reference, as **Appendix 2**. The letters of reference must be from persons able to provide adequate information about the Respondent's qualifications. References must include their name, mailing address, telephone number, and e-mail address. If during the past five (5) years the Respondent has directly or indirectly through a subcontract, performed services for or through a contract with the Department, the Respondent must include a Department reference.

The Department expects to use these references in its evaluation process.

■ E. COST SUBMISSION

All proposed costs are subject to the standards developed by the State Office of Policy and Management for determining the cost of contracts, grants, and other agreements with organizations that receive funding from the State. Be advised that the cost proposal is subject to revision prior to contract execution in order to ensure compliance with the OPM cost standards. 1. Budget. The remaining balance of the total funding request shall be for the activities required by this RFQ.

Specific terms and conditions pertaining to the payment process shall be set forth in the terms of the PSA.
